### I. Details of syllabus:

a) **General Intelligence & Reasoning:** This section covers verbal and non-verbal reasoning topics such as Number and Alphabetical Series, Coding and Decoding, Paper Folding and Cutting, Mirror Image, Embedded Figures, Analogy, Completing the Image, Odd One Out, Counting of Figures, Syllogism, Blood Relations, Matrix, Direction Sense, Mathematical Calculations, Ranking, and Arrangement of Words in Dictionary Order.

b) **Numeric Aptitude:** This section includes Number System, HCF and LCM, Percentage, Average, Time and Work, Profit and Loss, Ratio, Mixture and Alligation, Time, Speed and Distance, Simple Interest and Compound Interest, Geometry, Mensuration, Trigonometry, Data Interpretation, and Algebra.

c) **General English:** This section includes Spotting Errors, Fill in the Blanks, Synonyms, Antonyms, Spelling and Detection of Mis-spelt Words, Idioms and Phrases, One Word Substitution, Improvement of Sentences, and Comprehension Passage.

d) **General Awareness:** This section consists of History, Polity, Geography, Economy, Current Affairs, Static General Knowledge, Science, and Sports.

## 9. Dress-Code for Examination

## 11. Minimum Qualifying Standard

The minimum qualifying standard shall be:

- 35% marks in written test (multiple choice question).
- Candidate must have passed interview after passing the examination.

## 12. Selection Procedure Of Training

- The date of examination indicated in the advertisement is purely tentative in nature. Any change in the schedule of examination shall be brought to the notice of candidates only through the official website of the NIA Aviation Services Pvt. Ltd. No personal communication shall be made in this regard.
